Can I take my child to school if I have Covid? Self-isolation rules for children if parents test positive People under the age of 18 years and six months do not need to self-isolate if they have been in contact with someone with Covid

Pupils <u>across the UK have returned</u> to the classroom for <u>the spring term</u>. But with Covid-19 cases still very high, many pupils are having to self-isolate after testing positive for the virus.

There is also the question of what to do if a parent tests positive – here is everything you need to know. Can my child go to school if I have Covid?

People under the age of 18 years and six months do not need to self-isolate if they have been in contact with someone with Covid-19.

That means your child can go to school even if you have tested positive. However, as a precaution <u>they should test</u> regularly and you should try to limit contact with them.

If you are self-isolating you should not take your child to school, as you should not leave the house for any reason. You should find an alternative method for your child to attend school.

You should not send your child to school if they <u>have Covid symptoms</u>, and you should have them take a test as soon as possible.

What if there is a case in their class?

<u>Support bubbles</u> have been scrapped, meaning entire classes do not need to self-isolate if a child tests positive for the virus.

If there has been a case in your child's class, you will be contacted by NHS Test and Trace, informed your child has been in close contact with a positive case and advised to take a PCR test. Your child does not need to isolate while awaiting the PCR test.

When do I need to self-isolate?

You should self-isolate immediately if you have <u>any symptoms of Covid-19</u>, and order a PCR test <u>through the Government website</u>.

The NHS says the main symptoms of Covid are:

A high temperature

A new, continuous cough

A loss or change to your sense of smell or taste

However, people are <u>reporting other symptoms from the Omicron variant</u>, including a runny nose, sore throat, headache and fatigue.

You should also isolate if you test positive for the virus, either on a lateral flow or PCR test. If you test positive on a lateral flow you should order a confirmatory PCR.

If you are contacted by the NHS Test and Trace app for being a close contact of someone who has tested positive, you need to self-isolate.

However, you can avoid isolation if any of the following apply:

You are fully vaccinated – this means 14 days have passed since your second dose of a Covid-19 vaccine given by the NHS

You are under 18 years and six months old

You are taking part or have taken part in a Covid-19 vaccine trial

You are not able to get vaccinated for medical reasons

If you do not need to isolate, you are advised to take a lateral flow test every day for seven days after the close contact.

How long do I need to isolate for?

#### If you are fully vaccinated:

<u>The minimum self-isolation period</u> for people who test positive for Covid-19 has been <u>cut from 10 days to seven</u>. <u>This change</u> only applies <u>to fully-vaccinated people</u>, which currently counts <u>as having two doses of the jab</u>.

Fully-vaccinated people will have to test negative on <u>lateral flow tests</u> on day six and day seven, 24 hours apart, to be released from quarantine early.

If they do not, they must wait until they test negative on two consecutive days, or isolate for the full 10 days. Your self-isolation period includes the day your symptoms started (or the day you had the test, if you did not have symptoms) and the next 7-10 full days.

#### If you are not fully vaccinated:

People who have not had two doses of the vaccine <u>will still have to isolate for 10 days if they test positive</u>, or are a close contact with someone who has the virus.

If you test positive, your self-isolation period includes the day your symptoms started (or the day you had the test, if you did not have symptoms) and the next 10 full days.

If you are isolating as a close contact, NHS Test and Trace will tell you how long you need to isolate for. Does my child need to wear a mask at school?

All children in Year 7 and above should now wear face coverings in all indoor areas at school, including in classrooms, as well as on any public transport to and from school, unless they are exempt.

Children in Year 6 and below are not expected to wear a face covering.

#### Whole School Warning Letter regarding unauthorised leave of absence (holidays)

Here at Carclaze Community Primary School, we recognise that there are occasions when it is appropriate to authorise an absence, such as when a pupil is genuinely too ill to attend school, has a medical appointment that cannot be taken outside of school hours or a request for leave has been agreed in exceptional circumstances.

However, the Government does not support parents taking children out of school unless the school agrees this is appropriate under 'exceptional circumstances'. Any request for leave should be made in writing to the Headteacher using the school's request form.

If your child is absent from school without authorisation, you will be committing an offence under the Education Act 1996. We may submit a request to Cornwall Council for a Penalty Notice to be issued, in accordance with Sections 444A and 444B of the said Act. Penalty Notices are issued per liable parent, per child and each carry a fine of £60 if paid within 21 days or £120 if paid after this but within 28 days. Failure to pay the Penalty Notice may result in legal action. Absence not authorised by the school may result in a prosecution in the Magistrates' Court under Section 444(1) or Section 444(1A) of the Education Act 1996, leading to a fine of up to £2,500 and/or a custodial sentence. Cornwall Council may also apply for the costs incurred in taking the matter to Court.

'Parent' as set out in Section 576 of the Education Act 1996, defines parent to include: natural parents, whether they are married or not; any person or body who has parental responsibility for a child (as defined by the Children Act 1989) and; any person who, although not a natural parent, has care of a child. Having care of a child means a person with whom a child lives and who looks after a child, irrespective of what their relationship is with said child.

You are welcome to contact the school to discuss any concerns you may have regarding this or if you feel you would like advice or support in helping your child attend more regularly. Carclaze School is committed to maximising the education of all its pupils and aims to work with parents to ensure this can be achieved.

The decision to submit a request for the issue of a Penalty Notice will be considered when a child's attendance is deemed to be 'not regular'. The definition of 'not regular' in this instance is when it is below the threshold set by Cornwall Education Learning Trust (CELT). For all CELT schools, this attendance threshold is set at 96%, in line with national attendance data. In the Autumn Term, a child's attendance for the previous academic year will be considered before deciding on a course of action. From January onwards, the decision will be based on attendance data from the current academic year.
